A RESOLUTION AUTHORIZING AND DIRECTING THE CHAIRMAN OF THE ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS TO SUBMIT APPLICATION FOR FEDERAL ASSISTANCE UNDER SECTION 201, PUBLIC LAW 92-500, FOR (PAHSE) 2 OF THE SOUTHWEST ORANGE COUNTY FACILITY PLANNING PROGRAM AND FOR THE 201 DETAILED LAND APPLICATION EVALUATION PROGRAM; DIRECTING THE COUNTY PUBLIC UTILITIES DIRECTOR TO FURNISH REQUESTED INFORMATION TO STATE AND FEDERAL AGENCIES; PROVIDING AN (EFFETIVE) DATE.

PREMISES

1. Orange County has submitted a Grant Application and subsequently received a Grant Award from the U.S. Environmental Protection Agency to conduct Phase 1 of the Southwest Orange County 201 Facility Program, including related Environmental Impact Statement, (hereinafter EIS) studies.

2. Orange County has entered into a Consent Decree with the United States of America and the State of Florida, which includes a 201 Task Schedule for the Sand Lake Road Wastewater Treatment Facility.

3. The 201 Task Schedule requires the Florida Department of Environmental Regulation and the U.S. Environmental Protection Agency to approve grant requests for Phase 2 of the 201 Program and for the Detailed Land Application Evaluation Program by September 1, 1981.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS
OF ORANGE COUNTY:

Section 1. The Board of County Commissioners hereby authorizes and directs the Chairman to submit applications with the Florida Department of Environmental Regulation and the U.S. Environmental Protection Agency for federal assistance under Section 201, Public Law 92-500, for the Southwest Orange County Facilities Planning Program Step 1 grant increase for the 201 Phase 2 Program and the 201 Detailed Land application Evaluation Program.

Section 2. The Director of the Division of Public Utilities is hereby authorized and directed to furnish such information as the Florida Department of Environmental Regulation and the U.S. Environmental Protection Agency may reasonably request in connection with the above-mentioned applications.

Section 3. This Resolution shall take effect upon adoption.
