RESOLUTION

of the

ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

regarding

THE STATE'S REVOLVING LOAN PROGRAM, PURSUANT TO SECTION 403.1835, FLORIDA STATUTES, AUTHORIZING LOW INTEREST LOAN ASSISTANCE TO LOCAL GOVERNMENTS TO CONSTRUCT UTILITY LINES TO SERVE LOW INCOME COMMUNITIES AND PROVIDE WATER OR WASTEWATER SERVICES; ADOPTING A UTILITIES PLAN TO CARRY OUT THIS PROGRAM FOR THE HOLDEN HEIGHTS COMMUNITY IN ORANGE COUNTY

WHEREAS, the Florida Department of Environmental Protection (DEP) administers a state revolving loan program providing low interest loans to local governments to serve low or lower income communities; and

WHEREAS, Orange County has applied for such a loan to assist with the wastewater line extension into the Holden Heights community; and

WHEREAS, the loan program is a revolving loan fund and will be repaid over time; and

WHEREAS, the costs of extending the various lines will be paid for by assessments against benefited property; and

WHEREAS, Orange County Utilities has prepared a Facilities Plan as required by state law and by the rules implementing the State Revolving Fund Loan Program; and

WHEREAS, the Board of County Commissioners has reviewed said Facilities Plan and is utilizing this Resolution as a means of adopting said Facilities Plan for the Holden Heights community.

BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY AS FOLLOWS:

Section 1. Recitals.

The foregoing recitals are accurate and true, and constitute a part of this Resolution to implement use of the State Revolving Fund Loan Program in the Holden Heights community.

Section 2. Facilities Plan Adopted.

The Board of County Commissioners has reviewed a Facilities Plan for utility line construction in the Holden Heights community, and the purpose of this Resolution is to adopt the Facilities Plan, as required by Rule 62.503.350, Florida Administrative Code, in order to further qualify Orange County for participation in the State Revolving Fund Loan Program for the benefit of property owners in the Holden Heights community.

Section 3. Effective Date.

This Resolution shall take effect on the date of its adoption.
