# RESOLUTION

BUTLER CHAIN OF LAKES ADVISORY BOARD**

**Resolution No. 2006-M-20**

WHEREAS, the Windermere Water and Navigation Control District was created by special act of the Florida Legislature, chapter 63-1711, Laws of Florida ("District"); and

WHEREAS, section 25 of chapter 63-1711, Laws of Florida, as amended by chapter 85-474, Laws of Florida, established an advisory committee for the purpose of assisting and advising the Board of County Commissioners; and

WHEREAS, since its inception the advisory committee has been known as the Windermere Water and Navigation Control District Advisory Board (hereinafter the "Advisory Board"); and

WHEREAS, the Advisory Board has determined that its name has become a source of confusion to the citizens inside of and outside of the Windermere Water and Navigation Control District; and

WHEREAS, the Advisory Board has recommended that its name be changed from the Windermere Water and Navigation Control District Advisory Board to the Butler Chain of Lakes Advisory Board to more accurately reflect the geographic boundaries of the District; and

WHEREAS, the District is composed of and governed by the duly elected members of the Board of County Commissioners of Orange County; and

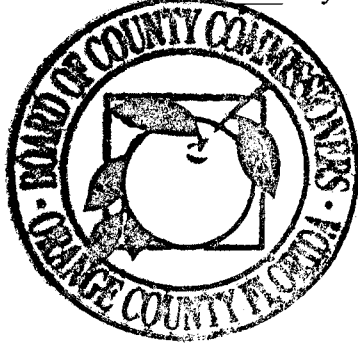
WHEREAS, the District accepts the recommendation of the Advisory Board and desires to change the name of the Advisory Board from the Windermere Water and Navigation Control Advisory Board to the Butler Chain of Lakes Advisory Board.

NOW THEREFORE, BE IT RESOLVED BY THE WINDERMERE WATER AND NAVIGATION CONTROL DISTRICT:

Section 1. Henceforth, the District's Advisory Board shall be known as the Butler Chain of Lakes Advisory Board.

Section 2. This Resolution shall be effective upon passage by the Orange County Board of County Commissioners sitting as the governing authority of the Windermere Water and Navigation Control District.
