ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

regarding

RESTORE ORLANDO

Resolution No. 2008-M-20

WHEREAS, the Florida Legislature has created the Enterprise Zone Community Contribution Tax Credit Program ("CCTC Program") to encourage donations to community development programs in low-income communities by providing contributors with a 50 percent credit against any state tax due for a taxable year; and

WHEREAS, Restore Orlando provides an array of programs to the residents of Holden Heights, an Enterprise Zone and Front Porch community; and

WHEREAS, Restore Orlando's educational program offers cultural activities and tutoring for children and parenting and health awareness classes for adults; and

WHEREAS, Restore Orlando's recreational program offers summer programs and camps specializing in martial arts, basketball, baseball, and performing arts; and

WHEREAS, Restore Orlando will be applying to the Executive Office of the Governor, Office of Tourism, Trade, and Economic Development to become a sponsored project under the CCTC Program; and

WHEREAS, in order for Restore Orlando to become a sponsored project under the CCTC Program, the Orange County Board of County Commissioners must adopt a resolution certifying that Restore Orlando programs are consistent with local plans and regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Orange County supports Restore Orlando's programs which provide educational and recreational services to the residents of Holden Heights.

Section 2. Restore Orlando's programs are consistent with the provisions of the Orange County Comprehensive Policy Plan and with all local plans and regulations.


Section 3. The Orange County Clerk to the Board of County Commissioners is hereby authorized and directed to file this resolution with the State of Florida, Office of Tourism, Trade and Economic Development of the Executive Office of the Governor, The Capitol, Suite 2001, Tallahassee, Florida 32399-0001, to enable Restore Orlando to obtain approval as a sponsored project.

Section 4. If any provision of this resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this resolution which can be given effect without the valid provision or application and to this end the provisions of this resolution are declared severable.


Section 5. This resolution shall take effect immediately.
