**THE STATE'S REVOLVING FUND LOAN PROGRAM,  
PURSUANT TO SECTION 403.1835, FLORIDA STATUTES,  
AUTHORIZING LOW INTEREST LOAN ASSISTANCE TO  
LOCAL GOVERNMENTS TO CONSTRUCT UTILITY LINES  
TO SERVE LOW INCOME COMMUNITIES AND PROVIDE  
WATER OR WASTEWATER SERVICES; ADOPTING A  
UTILITIES PLAN TO CARRY OUT THIS PROGRAM FOR THE  
WEST SOUTHWOOD SUBDIVISION GRAVITY SEWER  
REHABILITATION PROJECT IN ORANGE COUNTY**

**Resolution No. 2010-M-26**

**WHEREAS**, the Florida Department of Environmental Protection (DEP) administers a state revolving fund loan program providing low interest loans to local governments to serve low or lower income communities; and

**WHEREAS**, Orange County has applied for such a loan to assist with the wastewater improvements of the West Southwood Subdivision; and

**WHEREAS**, the proceeds of the state revolving loan will be utilized by the Orange County Utilities Department to cover the cost of rehabilitating the gravity sewer lines in the West Southwood Subdivision; and

**WHEREAS**, Orange County Utilities has prepared a Facilities Plan as required by state law and by the rules implementing the State Revolving Fund Loan Program; and

**WHEREAS**, the Board of County Commissioners has reviewed said Facilities Plan and by this Resolution adopts said Facilities Plan for the West Southwood Subdivision Gravity Sewer Rehabilitation Project.

**BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
ORANGE COUNTY:**

**Section 1. Recitals.** The foregoing recitals are accurate and true, and constitute a part of this Resolution to implement use of the State Revolving Fund Loan Program for West Southwood Gravity Sewer Rehabilitation Project.

**Section 2. Facilities Plan Adopted.** The Board of County Commissioners has reviewed a Facilities Plan for wastewater improvements in the West Southwood Subdivision, and the purpose of this Resolution is to adopt the Facilities Plan, as required by Rule 62.503.350, Florida Administrative Code, in order to further qualify Orange County for participation in the State Revolving Fund Loan Program for the benefit of property owners in the West Southwood Subdivision.

**Section 3. Effective Date.** This Resolution shall take effect on the date of its adoption.

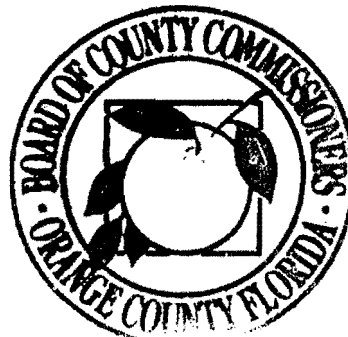
