**ESTABLISHING A NO TRUCK OR TRACTOR TRAILER
PARKING ZONE FOR FHWA VEHICLE CLASSIFICATIONS
6 THROUGH 13 AND A NO PARKING TOW AWAY ZONE FOR
THOSE SAME VEHICLE CLASSIFICATIONS ON AVALON
PARK BOULEVARD NORTHBOUND AND SOUTHBOUND
BETWEEN TANJA KING BOULEVARD AND
GOLDEN RAIN TREE BOULEVARD**

WHEREAS, the Orange County Board of County Commissioners (BCC) has determined that there is a history of parked trucks and tractor trailer vehicles causing an unsafe line of sight for motorists and pedestrians along the northbound and southbound portions of Avalon Park Boulevard between Tanja King Boulevard and Golden Rain Tree Boulevard;

WHEREAS, the BCC has determined that in order to mitigate the motorist and pedestrian safety concerns it is necessary for the BCC to prohibit FHWA vehicle classifications 6 through 13 from parking along Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard;

WHEREAS, establishment of restricted parking of those vehicle classifications along these portions of Avalon Park Boulevard will improve safety and reduce the potential for vehicle and pedestrian accidents;

WHEREAS, additionally, establishment of a no parking tow away zone along these portions of Avalon Park Boulevard shall also be included in this resolution; and

WHEREAS, the Avalon Park Property Owners Association originally brought this matter to Orange County's attention.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY, FLORIDA:**

**Section 1. Establishment of No Truck or Tractor Trailer Parking Zone for
FHWA Vehicle Classifications 6 through 13.** The Board of County Commissioners

hereby establishes a No Truck or Tractor Trailer Parking Zone for FHWA Vehicle Classifications 6 through 13 on Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard.

Section 2. Establishment of No Parking Tow Away Zones for FHWA Vehicle Classifications 6 through 13. The BCC hereby establishes a no parking tow away zone for FHWA Vehicle Classifications 6 through 13 on Avalon Park Boulevard northbound and southbound between Tanja King Boulevard and Golden Rain Tree Boulevard.

Section 3. Effective Date. This Resolution shall take effect upon the date of its adoption.
