

RESOLUTION

ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS

regarding

AUTHORIZATION TO CONVEY CERTAIN COUNTY PROPERTY INTERESTS TO THE CITY OF WINTER GARDEN, FLORIDA

Resolution No. 2016-M- 50

WHEREAS, Orange County ("County"), a charter county and political subdivision of the State of Florida, pursuant to its home rule power and Section 125.38, Florida Statutes, upon an application by the United States, the State of Florida, any political subdivision or agency thereof, any municipality of the State of Florida, or any corporation or not for profit entity organized for the purpose of promoting community interest and welfare, has authority to determine, upon such an application, that certain County property is not needed for County purposes and to convey such property, for nominal price or otherwise, to the State of Florida, any political subdivision or agency thereof, or any municipality of the State of Florida, or any corporation or not for profit entity organized for the purpose of promoting community interest and welfare;

WHEREAS, the County obtained an easement to a certain property by virtue of a Sidewalk Easement recorded on July 9, 1985, in Official Records Book 3661, Page 2099, of the Public Records of Orange County, Florida, a copy of which is attached hereto as

Exhibit “A” (“Sidewalk Easement”);

WHEREAS, by virtue of an annexation that occurred through Ordinance 16-22 adopted by the City Commission of the City of Winter Garden on March 24, 2016, the Sidewalk Easement is now located within the jurisdictional limits of the City of Winter Garden;

WHEREAS, the City of Winter Garden has applied to the County to be assigned the Sidewalk Easement for the public interest or welfare;

WHEREAS, the County has determined that, pursuant to the City of Winter Garden’s application and Section 5 of Ordinance 16-22, the Sidewalk Easement should be assigned to the City of Winter Garden, and such conveyance is in the public interest; and

WHEREAS, the City of Winter Garden is qualified, as a municipality under the laws of the State of Florida, to be assigned the Sidewalk Easement pursuant to Section 125.38, Florida Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

1. The Board hereby determines that the Sidewalk Easement is not needed for County purposes and that it is in the best interest of Orange County and the City of Winter Garden that the Sidewalk Easement be conveyed to the City of Winter Garden.
2. The Board directs that all of the County’s right, title, and interest in the Sidewalk Easement be conveyed to the City of Winter Garden and, as consideration, the City of Winter Garden will assume all of the County’s rights, duties, and obligations that exist under the terms and conditions of the Sidewalk Easement.

3. The Board directs the Orange County Mayor to execute and deliver an Assignment of Easement to effectuate such conveyance, and that staff do all things necessary and appropriate to conclude this transaction.

4. The Board hereby directs that a certified copy of this Resolution shall be forwarded forthwith to the City Manager of the City of Winter Garden.

5. This Resolution shall become effective upon its adoption by the Board.

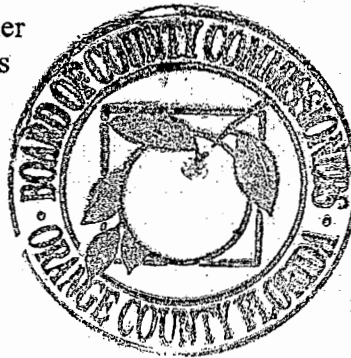

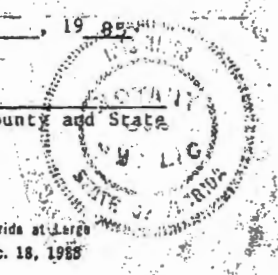

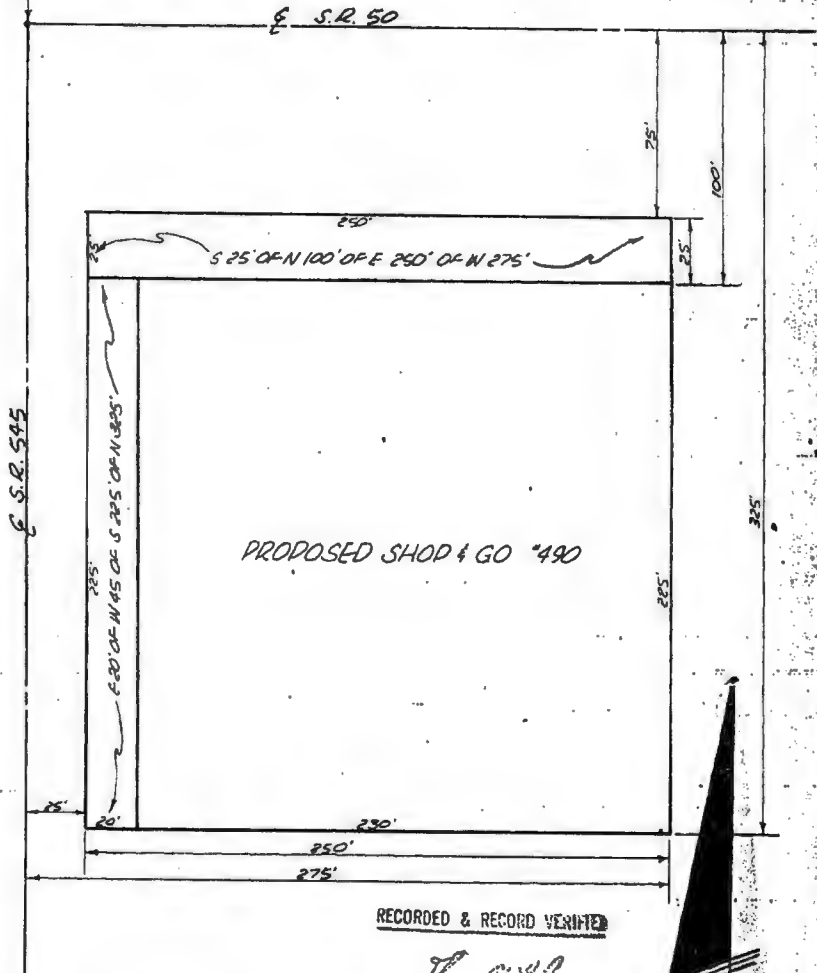
