

RESOLUTION NO. 82-LEG-04

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY DIRECTED TO THE GOVERNOR AND CABINET OF THE STATE OF FLORIDA SITTING IN THEIR CAPACITY AS THE POWER PLANT SITING BOARD: PETITIONING THE POWER PLANT SITING BOARD TO MODIFY THE RECOMMENDED CONDITIONS OF CERTIFICATION: PROVIDING AN EFFECTIVE DATE.

PREMISES

1. The Board of County Commissioners of Orange County is a party to the Orlando Utilities Commission Curtis H. Stanton Power Plant, Unit No. 1, Site Certification Proceedings, DOAH Case No. 81-1431.
2. The Recommended Conditions of Certification contain provisions related to the management and control of air quality in Orange County and the State of Florida.
3. The Board of County Commissioners asked the Orlando Utilities Commission to agree to maintain the Curtis H. Stanton Power Plant, if certified, so that it would never violate now existing federal and state air quality standards and emission limitations.
4. The Orlando Utilities Commission adopted a Resolution dated November 18, 1982, in which it recorded its intention to use the best available control technology and to maintain its purpose not to relax any air quality requirements presently in effect with respect to the operation of the Curtis H. Stanton Power Plant.
5. The Board of County Commissioners believes that Proposed Condition of Certification XXVI and the proposed condition of certification set forth in Section 1 of the Resolution, if adopted by the Siting Board and imposed upon the Orlando Utilities Commission for Unit 1, will protect the broad interests of the public in concert with other existing conditions. It is the position of the Board that the adoption of the proposed modification set forth in Section 1 hereof should not be a cause for delay in the certification proceedings.

ACCORDINGLY, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. The Board of County Commissioners hereby petitions the Power Plant Siting Board to modify the Recommended Conditions of Certification of the Curtis H. Stanton Power Plant, Unit No. 1, to require the Orlando Utilities Commission to use the currently certified best available control technology and comply with now existing air quality standards and emission limitations for so long as it shall operate the Curtis H. Stanton Power Plant, Unit 1.


Section 2. The Resolution shall take effect upon adoption.
