

A RESOLUTION AUTHORIZING THE USE OF ORANGE COUNTY PROPERTY
FOR BINGO PLAYING: ESTABLISHING STANDARDS FOR ACTUAL USE.

PREMISES

1. Florida Statute Section 849.093 permits the playing of "bingo games" under the conditions set forth in the statute.
2. Said Statute restricts the playing of such "bingo games" to certain types of premises.
3. Property owned by a county is included within the allowable premises.
4. Before county property can be utilized for the conduct of "bingo games", an ordinance or resolution specifically authorizing the use of county property must have been adopted.
5. Orange County desires to authorize the use of the East Orange County Service Center and the Marks Street Senior Citizen Center for "bingo games".

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY:

Section 1. The East Orange County Service Center and Marks Street Senior Citizen Center may be utilized for the conduct of "bingo games", to the extent otherwise permitted by §849.093, Florida Statute, upon compliance with the procedures and requirements of this resolution.

Section 2. Use of this county property for the conduct of "bingo games" shall be limited to those organizations described in §849.093(2), Florida Statute. Orange County intends to limit the use to non-profit organizations or veterans organizations, and does not intend to authorize use of this property by any organization which is not engaged in efforts of the type set forth in §849.093(2).

Section 3. Prior to conducting such "bingo games" at these locations, the sponsoring agency shall submit to the County Administrator's Office a form which shall (1) identify the organization's sales tax exemption number, (2) identify the organization, (3) state how long the organization has been in existence, (4) identify the date and hours of the proposed use (5) state the names and addresses

of members of the organization who will be responsible for the conduct of the "bingo games", and (6) state that the persons responsible for conducting "bingo games" have reviewed §849.093 and are familiar with the restrictions on and requirements for the conduct of "bingo games".

Section 4 - Insurance/Indemnification. The sponsoring agency shall provide Orange County with a Certificate of Insurance showing that the agency has general liability insurance in an amount to be determined by the Risk Management Department covering the agency's conduct and operation of "bingo games" for any and all claims which might arise out of agency's use of county property for the conduct of "bingo games". The agency shall hold Orange County harmless from all such claims, costs and expenses, including attorneys' fees. The agency shall be responsible for any property damage caused to Orange County property arising out of the agency's use of county property for the conduct of "bingo games".

Section 5 - Charges. The agency shall be responsible for utilities charges and expenses accruing by reason of agency's use of county property. The agency may, from time to time, be required to maintain a security deposit in the amount of \$500 to be held by the County to ensure payment of all expenses.

Section 6 - Cleanup. The agency shall be responsible for leaving the county property used in as good as and as clean as a condition as it was when the agency commenced its use. Any expenses accruing to Orange County by reason of county cleaning used property will be billed to the using agency.

Section 7. Orange County will not be responsible for any operations conducted by the agency. Specifically, Orange County has no responsibility for the agency's compliance with §849.093, Florida Statute.

Section 8. A copy of the written information required under Section 3 of this resolution shall be delivered by the agency to the Orange County Sheriff's Department and to the Orange County State Attorney's Office.

Section 9. This resolution shall be effective upon its adoption by the Board of County Commissioners.
