RESOLUTION NO. 85-M-01

A Resolution establishing a system of fines pursuant to Ordinance No. 85-01.

PREMISES

A. In an effort to correct problems which have arisen with regard to parking of motor vehicles within the unincorporated areas of Orange County, the Board of County Commissioners has adopted Ordinance No. 85-01.

B. Pursuant to said Ordinance, the Board of County Commissioners is granted the authority to adopt, by Resolution, a schedule of fines for parking violations for which payment may be made in accordance with provisions set forth within said ordinance.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. The Board of County Commissioners does hereby adopt the following schedule of fines for violations of Ordinance No. 85-01, relating to parking in Orange County:

No parking, stopping or standing	\$10.00
No parking - Here to corner	\$10.00
No parking - Between signs	\$10.00
No parking - This side	\$10.00
No parking - On parkway	\$10.00
Obstructing traffic	\$10.00
Bus stop	\$10.00
Handicapped persons only	\$20.00
On sidewalk	\$10.00
On crosswalk	\$10.00
Double park	\$10.00
Blocking driveway	\$10.00
Blocking fire hydrant	\$20.00
Parking within 30 feet of traffic control device	\$10.00
No parking - Official vehicles only	\$10.00
Parking for assigned personnel only	\$10.00
No parking - Law enforcement vehicle only; tow away zone	\$10.00
Left wheels to curb (on two-way streets)	\$10.00
Emergency vehicles only - Tow away zone	\$10.00
No parking on pavement or parkway	\$10.00
Handicapped loading	\$20.00
Wheelchair ramp	\$20.00
Parking wrong way on one-way street	\$10.00
No parking - County prison van	\$10.00
Parking within 30 feet of nearest rail at railroad crossing	\$10.00
Parking overtime (limit authorized in zone)	\$10.00
Parking over line	\$10.00
Parking in fire lane	\$20.00
Dual rear wheel vehicle	\$20.00
