RESOLUTION NO. 86-F/EMS-03

A RESOLUTION OF ORANGE COUNTY, FLORIDA, AMENDING THE URBAN AND RURAL FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT RESOLUTIONS TO CONSOLIDATE THE URBAN AND RURAL FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNITS INTO ONE MUNICIPAL SERVICE TAXING UNIT TO BE KNOWN AS THE ORANGE COUNTY FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT; AND PROVIDING AN EFFECTIVE DATE.

PREMISES

1. On May 12, 1981, by separate Resolutions, the Board of County Commissioners of Orange County, Florida, adopted the Urban and Rural Fire Protection and Emergency Medical Services Municipal Service Taxing Units. Said Resolutions are recorded at Official Records Book 3194, Page 1039, and Official Records Book 3194, Page 1042, Public Records of Orange County, Florida.

2. On June 28, 1983, the Board of County Commissioners adopted two Resolutions to amend the legal descriptions for the Urban and Rural Fire Protection and Emergency Medical Services Municipal Service Taxing Units. The effect of the Resolutions was to decrease the geographic boundaries of the Rural Fire Protection and Emergency Medical Services MSTU and to increase the geographic boundaries of the Urban Fire Protection and Emergency Medical Services MSTU.

3. The Board of County Commissioners desires to amend the aforesaid Resolutions to consolidate the Urban and Rural Fire Protection and Emergency Medical Services Municipal Service Taxing Units into one Municipal Service Taxing Unit known as the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. There is hereby consolidated into one municipal service taxing unit to be known as the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit that certain property described in and subject to the Urban Fire Protection and Emergency Medical Services Municipal Service Taxing Unit as set forth in that Resolution recorded at Official Records Book 3194, Page 1039, Public Records of Orange County, Florida, and amended by Resolution No. 83-F/EMS-03, and the Rural Fire Protection and Emergency Medical Services Municipal Service Taxing Unit, as set forth in that Resolution recorded at Official

Records Book 3194, Page 1042, Public Records of Orange County, Florida, as amended by Resolution No. 83-F/EMS-02.

Section 2. Except as specifically amended by this Resolution, Resolutions No. 83-F/EMS-02 and 83-F/EMS-03 and those Resolutions adopted on May 12, 1981 shall continue in full force and effect.

Section 3. This Resolution shall take effect upon its adoption.
