RESOLUTION NO. 86-M-07

A RESOLUTION RELATING TO ADMINISTRATIVE FEES; ESTABLISHING A FEE FOR VACATING OF COUNTY ROADS, RIGHTS-OF-WAY, EASEMENTS AND PARKS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

RECITALS:

1. Orange County has been authorized by Orange County Ordinance No. 80-1, to regulate the vacating of County roads, rights-of-way, easements and parks in the unincorporated area of Orange County, to adopt regulations for that purpose and to establish fees and charges for the services and activities necessary to the administration of that program.

2. County personnel involved with administering that program have advised the Board concerning the time and expense involved with processing and reviewing petitions to vacate.

3. The Board has received sufficient information to enable it to determine the economic impact of this regulation and determines that no additional information is needed.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. Petition to Vacate Fee. The Board hereby establishes the following fees for petitions to vacate County roads, rights-of-way, easements and parks and determines that these fees represent the actual costs expended by Orange County to administer that program:

A. Application Fee (\$100.00 refundable if no public hearing is held) \$500.00

Section 2. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application and to this end the provisions of this Resolution are declared severable.

Section 3. Effective Date. This Resolution shall take effect immediately upon its adoption.
