RESOLUTION NO. 86-M-27

1 A RESOLUTION AMENDING ORANGE COUNTY RESO-
2 LUTION NO. 86-M-24 TO INCREASE THE MEMBER-
3 SHIP OF THE "COMMITTEE FOR ORANGE-ORLANDO
4 PROFESSIONAL AMATEUR SPORTS" FROM FIFTEEN
5 (15) MEMBERS TO SEVENTEEN (17) MEMBERS;
6 PROVIDING FOR AN EFFECTIVE DATE.

7 WHEREAS, the Board of County Commissioners of Orange
8 County, Florida did on July 7, 1986 pass Resolution No.
9 86-M-24 creating the "Committee for Orange-Orlando Pro-
10 fessional and Amateur Sports" ("Committee"); and

11 WHEREAS, since passage of the Resolution many qualified
12 individuals with diverse backgrounds and expertise have come
13 forward to volunteer their services to the Committee; and

14 WHEREAS, the Board has determined that the creation of
15 two additional appointments to the Committee will enhance the
16 make-up of the Committee and ultimately its study and recom-
17 mendations,

18 NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
19 COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

20 Section 1. That Section 2 of Orange County Reso-
21 lution No. 86-M-24 is hereby amended as follows:

22 Section 2. Membership and Organization.

23 (a) The Committee shall consist of ~~15~~ 17
24 members. All terms shall be for a period of four
25 (4) years.

26 (1) Three of the members shall be non-elected
27 citizens appointed by the Mayor of the City of
28 Orlando with concurrence of the city council.
29 ~~Three~~ Five of the members shall be non-
30 elected citizens appointed by the Board of
31 County Commissioners of Orange County, Florida.

32 (2) Three of the members shall be the follow-
33 ing ex officio members who shall have the same
34 full membership in every respect, including

voting rights, as each of the other twelve
fourteen members: A member of the city
council of the City of Orlando, to be
designated by it; a member of the Board of
County Commissioners of Orange County, to be
designated by it; a member of the Orange
County Legislative Delegation, to be designat-
ed by it.

Section 2. This Resolution shall become effective
upon passage.
