RESOLUTION NO. 86-M-49

A RESOLUTION CONVEYING CERTAIN SURPLUS  
COUNTY PERSONAL PROPERTY TO THE MARKS  
STREET SENIOR CENTER, INC., A NON PROFIT  
FLORIDA CORPORATION.

PREMISES

1. The Board of County Commissioners is in receipt of the application of the **Marks Street Senior Center, Inc.**, a non profit Florida corporation, for conveyance to it of certain surplus personal property presently owned by the County but located upon the premises of said Senior Center and utilized by the personnel and patrons of the Senior Center. Said application is memorialized in a certain Agreement between the Senior Center and the County, approved by the Board of County Commissioners at their meeting of January 23, 1984.

2. The Board of County Commissioners finds that the said **Marks Street Senior Center, Inc.** is a valid and subsisting non profit corporation of the State of Florida and promotes the community interest and welfare of the residents of Orange County and is therefore qualified to receive such surplus personal property for a nominal consideration under the provisions of Section 125.38, Fla. Stat. (1985).

3. The Board of County Commissioners has been informed and hereby finds that the aforementioned personal property, a list of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is in fact surplus and no longer needed for County purposes, and that the same should be conveyed to the said Senior Center for the consideration of **ONE (\$1.00) Dollar.**

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF ORANGE COUNTY:

THAT, the personal property owned by the County and listed on Exhibit "A" attached hereto and incorporated herein by reference is hereby declared surplus and the same be conveyed to the Marks Street Senior Center, Inc. upon payment to the County of ONE (\$1.00) DOLLAR and that the County Administrator be, and hereby is, authorized to execute on behalf of the County all documents necessary to accomplish transfer of title thereto.
