2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF ORANGE COUNTY, FLORIDA,
4 PERTAINING TO EXPENDING A REASONABLE SUM OF
5 MONEY FOR LUNCHESES WITH PUBLIC OFFICIALS AND
6 EXPENDING REASONABLE SUMS OF MONEY FOR AN
7 ANNUAL APPRECIATION LUNCH OR DINNER FOR THE
8 ORANGE COUNTY LEGISLATIVE DELEGATION;
9 PROVIDING AN AUTHORIZATION TO EXPEND A
10 REASONABLE SUM OF MONEY FOR LUNCH WITH OTHER
11 PUBLIC OFFICIALS; PROVIDING AN AUTHORIZATION
12 TO EXPEND REASONABLE SUMS OF MONEY FOR AN
13 ANNUAL APPRECIATION LUNCH OR DINNER FOR THE
14 ORANGE COUNTY LEGISLATIVE DELEGATION; AND
15 PROVIDING AN EFFECTIVE DATE.

16 WHEREAS, Article VIII, Section 1(g) of the Constitution
17 of the State of Florida, provides in pertinent part that
18 counties operating under county charters shall have all
19 powers of local self-government not inconsistent with general
20 law, or with special law approved by vote of the electors; and

21 WHEREAS, Section 125.01(1)(t) provides in pertinent part
22 that the legislative and governing body of a county to the
23 extent not inconsistent with general or special law shall
24 have the power to adopt resolutions necessary for the
25 exercise of its powers; and

26 WHEREAS, Article I, Section 103, Orange County Charter,
27 provides that Orange County shall have all powers of local
28 self-government not inconsistent with general law or special
29 law approved by vote of the electors; and

30 WHEREAS, the Board of County Commissioners, pursuant to
31 the Home Rule powers granted by the Constitution of the State
32 of Florida, the Florida Statutes, and the Orange County
33 Charter desires to adopt a resolution not inconsistent with
34 general law or special law approved by vote of the electors
35 pertaining to expending reasonable sums of money for lunch
36 with other public officials and expending reasonable sums of
money for an annual appreciation lunch or dinner for the
Orange County Legislative Delegation.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

SECTION 1. AUTHORIZATION OF A REASONABLE SUM OF MONEY FOR LUNCHESES WITH PUBLIC OFFICIALS. The Board of County Commissioners is hereby authorized to expend a reasonable sum of money for lunch with other public officials to be held not more than monthly.

SECTION 2. AUTHORIZATION OF REASONABLE SUMS OF MONEY FOR AN APPRECIATION DINNER FOR ORANGE COUNTY LEGISLATIVE DELEGATION. The Board of County Commissioners is hereby authorized to expend reasonable sums of money for an annual appreciation lunch or dinner for the Orange County Legislative Delegation.

SECTION 3. EFFECTIVE DATE. This resolution shall become effective on the date of its adoption.
