RESOLUTION NO. 87-M- 31

A RESOLUTION CONVEYING CERTAIN SURPLUS COUNTY
PERSONAL PROPERTY TO VARIOUS NON-PROFIT FLORIDA
CORPORATIONS RENDERING SERVICES TO THE INMATES
OF THE COUNTY CORRECTIONS DIVISION.

PREMISES

1. The Board of County Commissioners is in receipt of requests from various non-profit Florida corporations, each of which provides social, welfare and counseling services to inmates of the County Corrections Division. These non-profit corporations are:

OPERATION TURNAROUND, INC.

ORANGE COUNTY JAIL MINISTRY, INC.

GOOD NEWS JAIL AND PRISON MINISTRY, INC.

Said requests are directed toward the acquisition by each non-profit corporation of one automobile presently owned by Orange County and assigned for use to the County Corrections Division. All of said automobiles are beyond the point of being economically feasible to maintain and continue in County service and are, therefore, surplus property with minimal commercial value.

2. The Board of County Commissioners finds that the said non-profit corporations mentioned hereinabove are valid and subsisting non-profit corporations of the State of Florida and that their operations promote the welfare and rehabilitation of inmates of the County Corrections Division and thereby promote the community interest and welfare of Orange County and its residents. Said non-profit corporations are therefore qualified to receive such surplus personal property, as requested, for a nominal consideration under the provisions of Section 125.38, Fla. Stat.(1985).

3. The Board of County Commissioners has been informed and hereby finds that each of the automobiles described hereunder is in fact surplus and no longer needed for County purposes, and that the same should be and are conveyed to the non-profit corporations set opposite each said automobile description for the consideration of ONE (\$1.00) DOLLAR each.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY:

Section 1. That, the following automobiles owned by Orange County are hereby declared surplus and the same are to be conveyed to the non-profit corporations set opposite each vehicle described herein, such conveyance to take place upon payment to the County of the sum of ONE (\$1.00) DOLLAR for each automobile so conveyed:

Section 3. This Resolution shall take effect upon adoption.


