9 A RESOLUTION APPROVING THE CONVEYANCE OF
10 CERTAIN LANDS TO STATE OF FLORIDA
11 DEPARTMENT OF TRANSPORTATION FOR SUM
12 CERTAIN.

13 WHEREAS, the State of Florida Department of Transporta-
14 tion proposes to construct and improve State Road 400 (I-4),
15 Section 75280-2462 in Orange County, Florida; and

16 WHEREAS, it is necessary that certain lands now owned by
17 Orange County be acquired by the State of Florida for the use
18 and benefit of the State of Florida Department of Transporta-
19 tion to construct and improve State Road 400 (I-4), Section
20 75280-2462; and

21 WHEREAS, said lands are not needed for County purposes;
22 and

23 WHEREAS, the State of Florida Department of Transporta-
24 tion has made application to Orange County to execute and
25 deliver to the State of Florida Department of Transportation
26 a deed in favor of the State of Florida, conveying all
27 rights, title and interest that Orange County has in and to
28 said lands required for right of way for said State Road, and
29 said request has been duly considered.

30 NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COM-
31 MISSION OF ORANGE COUNTY, FLORIDA:

32 1. The application of the State of Florida Department
33 of Transportation for a deed to said lands is for right of
34 way purposes which are in the public or community interest
35 and for the public welfare, and the lands needed for right of
36 way and other road purposes are not needed for County pur-
poses.

2. A deed in favor of the State of Florida Department
of Transportation conveying all right, title and interest of

Orange County in and to said lands required for right of way and other road purposes shall be drawn and executed by the County Commission.
