1 RESOLUTION NO. 88-M- 35

2 A RESOLUTION REQUESTING THE TRUSTEES OF THE
3 INTERNAL IMPROVEMENTS TRUST FUND TO ENTER
4 INTO A SOVEREIGNTY SUBMERGED LAND LEASE FOR
5 CERTAIN LANDS SUBMERGED UNDER LAKE CARLTON
6 AND LAKE BEAUCLAIR AND FURTHER REQUESTING A
7 WAIVER OF ALL FEES IN CONNECTION THEREWITH;
8 AND PROVIDING AN EFFECTIVE DATE.

9 WHEREAS, the Orange County Parks and Recreation
10 Department and Orange County, Florida desire to construct
11 boat slips and finger piers on Lake Carlton and boat slips,
12 finger piers and an eight foot square platform on Lake
13 Beauclair, all the foregoing construction projects being
14 designed and intended for public recreation and the use of
15 recreational boaters; and

16 WHEREAS, the construction of the aforementioned
17 public recreation projects requires that Orange County enter
18 into a sovereignty submerged land lease with the Trustees of
19 the Internal Improvement Trust Fund on such terms and
20 conditions as may be mutually agreeable to the said County
21 and said Trustees; and

22 WHEREAS, it is in the best interests of Orange
23 County and its residents that Orange County request of the
24 said Trustees that all fees in connection with said
25 sovereignty submerged land lease be waived by the said
26 Trustees.

27 NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY
28 COMMISSION OF ORANGE COUNTY, FLORIDA:

29 SECTION 1. Request For Sovereignty Submerged Land
30 Lease and Waiver of Fees.

31 The County Commission does hereby request the
32 Trustees of the Internal Improvement Trust Fund, as lessor,
33 to enter into a sovereignty submerged land lease with Orange
34 County, Florida, as lessee; such lease to include as the
35 demised premises such submerged lands in Lake Carlton and
36 Lake Beauclair as may be required to permit construction
thereon or thereover of certain boat slips, finger piers and
a platform.

SECTION 2. Empowerment for Execution.

Upon recommendation of the County Administrator, or
his designee, that the terms and conditions of the
aforementioned lease are in the best interests of Orange
County, the Chairman of the Orange County Commission is
hereby authorized to execute the aforementioned lease on

1 behalf of Orange County, as lessee, from the Trustees of the
2 Internal Improvement Trust Fund, as lessor, and the County
3 Administrator, or his designee, is authorized to do all other
4 things necessary to implement the aforementioned lease.

5 SECTION 3. Effective Date.

6 This Resolution shall take effect upon adoption.
