

RESOLUTION NO. 88-M-43

A RESOLUTION ABANDONING ANY PROPERTY INTEREST WHICH ORANGE COUNTY MAY HAVE IN A CERTAIN PARCEL OF LAND ABUTTING AND/OR UNDER THE SURFACE WATERS OF LAKE KILLARNEY; PROVIDING FOR THE REMOVAL OF A FISHING PIER THEREON; PROVIDING FOR THE MEMORIALIZING OF SUCH ABANDONMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, due to an administrative error, the Board of County Commissions of Orange County, Florida, on or about April 1, 1976, certified to the State of Florida the ownership by Orange County of a certain parcel of real estate abutting or lying under the surface waters of Lake Killarney, said parcel being more particularly described as follows:

Orange County, Florida; Section 2, Township 22, Range 29, Southeast 1/4, West of Lot 24, AND vacated street, North Block A, Glenco Subdivision (Plat Book L, Page 132).

WHEREAS, pursuant to and as a result of such certification, Orange County constructed and maintained, and still does maintain, a small fishing pier upon the aforementioned parcel of real estate; and

WHEREAS, the aforementioned fishing pier is maintained upon property to which Orange County has no legal right and the fishing pier, itself, and the maintenance thereof constitute a public nuisance which is adverse to the health, safety and welfare of the residents of the neighborhood surrounding the said fishing pier; and

WHEREAS, it is in the best interest of Orange County that Orange County no longer maintain the aforementioned nuisance and that Orange County abandon publicly any claim whatsoever which it may have or purport to have to the aforementioned parcel of real estate.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSION OF ORANGE COUNTY, FLORIDA:

Section 1. Abandonment of Purported Interest.  
Orange County, Florida does now and forever abandon any

1 interest, real or purported, whatsoever, which said County  
2 may have in the following described real estate:

3 Orange County, Florida; Section 2, Township  
4 22, Range 29, Southeast 1/4, West of Lot 24,  
AND vacated street, North Block A, Glenco  
Subdivision (Plat Book L, Page 132).

5 Section 2. Removal of Fishing Pier. The Manager of the  
6 Orange County Parks and Recreation Department is hereby  
7 authorized and instructed to take all steps necessary to  
8 cause the immediate removal of the fishing pier located upon  
9 the parcel of real estate described in Section 1 of this  
10 Resolution.

11 Section 3. Recording. The Clerk to the Commission is  
12 hereby authorized to immediately record a certified copy of  
13 this Resolution in the Official Records of Orange County and  
14 secure a proper indexing therein to this Resolution in order  
15 to properly record Orange County's abandonment of interest in  
16 the real estate which is the subject of this Resolution.

17 Section 4. Effective Date. This Resolution shall take  
18 effect upon adoption.
