2 A RESOLUTION APPROVING A MINOR AMENDMENT TO
3 THE PREVIOUSLY APPROVED MAP OF RESERVATION
4 FOR JOHN YOUNG PARKWAY FROM SAND LAKE ROAD
5 TO INTERSTATE 4.

6 WHEREAS, Section 336.02, Florida Statutes, as amended,
7 invests the commissioners of a county with the general
8 superintendence and control of county roads within its
9 county; and

10 WHEREAS, Section 336.02 authorizes the commissioners to
11 establish new roads and change or discontinue old roads; and

12 WHEREAS, consistent with these powers, Section 336.02
13 authorizes the commissioners to approve maps of reservation
14 for any road within the county's jurisdiction;

15 WHEREAS, Orange County Ordinance No. 84-21, as amended by
16 Ordinance No. 88-12, authorizes the Board of County
17 Commissioners to approve maps of reservation by Resolution,
18 and to amend such maps;

19 WHEREAS, the original map of reservation for John Young
20 Parkway from Sand Lake Road to Interstate 4, was approved by
21 the Board of County Commissioners on August 17, 1987 by
22 Resolution No. 87-M-29, and it is recorded in State and
23 County Road Reservation Map Book 1, Pages 21-29;

24 WHEREAS, an amendment to that original map of reservation
25 is proposed, and such amendment will affect less than five
26 percent (5%) of the total area within the original map; and

27 WHEREAS, the affected property owners have been notified
28 of this proposed amendment.

29 NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE BOARD OF
30 COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

31 1. The minor amendment to the original map of
32 reservation for John Young Parkway from Sand Lake Road to
33 Interstate 4 is approved. It is recorded in State and County
34 Road Reservation Map Book 1, Pages 109 & 110.

35 2. This Resolution shall become effective on the date
36 of its adoption.
