

RESOLUTION NO. 90-M-36

A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY, FLORIDA,
PERTAINING TO SETTING A MONTHLY TRAVEL
ALLOWANCE FOR COUNTY COMMISSIONERS;
PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article VIII, Section 1(q) of the Constitution
of the State of Florida, provides in pertinent part that the
governing body of a county operating under a Charter may
enact county ordinances not inconsistent with general law; and

WHEREAS, Chapter 112, Florida Statutes, does not pre-empt
local governments from adopting their own per diem and travel
allowance provisions; and

WHEREAS, the Board of County Commissioners of Orange
County, Florida, have adopted Ordinance Number 90-1
authorizing the Board to establish a per diem and travel
allowance policy by resolution; and

WHEREAS, a Commissioner in the normal course of
conducting the business is expected to travel approximately
one thousand (1,000) miles per month; and

WHEREAS, Section 112.061(7)(d)(1), Florida Statutes, has
established that twenty cents (20¢) per mile traveled is a
reasonable expense incident to the ownership and operation of
an automobile.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF ORANGE COUNTY, FLORIDA, THAT:

Section 1. Each member of the Board of County
Commissioners of Orange County, Florida, shall receive a
travel allowance of Two Hundred Dollars (\$200.00) per month
as reimbursement for use of a privately owned vehicle for
travel on official business. Said amount is found to be
reasonable, taking into account the customary use of the
automobile, the roads customarily traveled, and the expenses
incident to the ownership of an automobile.

Section 2. The effective date of this Resolution shall
relate back to February 5, 1990 (the date of adoption of

5 repealed.
