RESOLUTION NO. 90-M-57

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA, AMENDING SECTION 2d OF RESOLUTION 90-M-21 TO PROVIDE THAT TWO RATHER THAN THREE MEMBERS OF THE CHILDREN, YOUTH AND FAMILY SERVICES ADVISORY BOARD SHALL BE APPOINTED FOR A TERM OF TWO YEARS.

WHEREAS, the Board of County Commissioners of Orange County, Florida, on March 26, 1990, passed Resolution 90-M-21 which created a permanent and perpetual Orange County Children, Youth and Family Services Advisory Board to consist of seven (7) members appointed by the Board of County Commissioners; and

WHEREAS, Section 2d of Resolution 90-M-21 contains a scrivener's error which would result in eight (8) rather than seven (7) members upon commencement of staggered terms on January 1, 1991; and

WHEREAS, the Board of County Commissioners desires to amend Section 2d of Resolution 90-M-21.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Section 2d of Resolution 90-M-21 is hereby amended to read as follows:

~~Each member shall serve a term of three (3) years and will be eligible for reappointment.~~ All initial appointments will ~~shall~~ be made for the remainder of the calendar year 1990, ~~and additionally as follows~~ In order to achieve continuity through the staggering of terms, appointments which shall commence on January 1, 1991 shall be made in the following manner: two (2) members shall be appointed for a term of one (1) year, ~~three (3)~~ two (2) members shall be appointed for a term of two (2) years and three (3) members shall be appointed for a term of three (3) years. All subsequent appointments shall be for a term of three (3) years. Members will be eligible for reappointment.

Section 2. Effective Date. This Resolution shall become effective upon the date of passage.
