RESOLUTION NO. 91-M-64

A RESOLUTION PERTAINING TO THE LAKE JOHNS WATER AND NAVIGATION CONTROL SPECIAL DISTRICT IN ORANGE COUNTY, FLORIDA; ABOLISHING THE LAKE JOHNS WATER AND NAVIGATION CONTROL DISTRICT (CREATED BY CHAPTER 65-2017, SPECIAL LAWS OF FLORIDA, AS CODIFIED IN SECTIONS 33-71 THROUGH 33-97 OF THE RECODIFIED ORANGE COUNTY CODE); PROVIDING FOR FILING WITH THE FLORIDA SPECIAL DISTRICT INFORMATION PROGRAM AND ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS WITHIN THIRY (30) DAYS OF ITS EFFECTIVE DATE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Orange County Board of County Commissioners finds that there is no longer a need for the Lake Johns Water and Navigation Control District;

WHEREAS, the Orange County Board of County Commissioners has confirmed that no municipalities will be affected by the abolition of the Lake Johns Water and Navigation Control District;

WHEREAS, pursuant to Sections 2 and 3 of Chapter 65-2017, the Special Act creating the Lake Johns Water and Navigation Control District, the Board of County Commissioners of Orange County is the "governing authority" of the Lake Johns Water and Navigation Control District;

WHEREAS, pursuant to Florida Statute 189.4043(1)(b), the Lake Johns Water and Navigation Control District may be abolished by the Orange County Board of County Commissioners, acting as the governing authority of the Lake Johns Water and Navigation Control District.

IT IS RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA, IN ITS CAPACITY AS THE GOVERNING AUTHORITY OF THE LAKE JOHNS WATER AND NAVIGATION CONTROL DISTRICT.

Section 1. District Abolished. That the Lake Johns Water and Navigation Control District is abolished and hereinafter shall cease to exist as a special district, and all of the terms of Chapter 65-2017, as codified in Sections 33-71 through 33-97 of the recodified Orange County Code shall become null and void as of the effective date of this Resolution.

Section 2. As required by Florida Statute 189.4043(1)(b), a copy of this Resolution shall be filed within thirty (30) days of its effective date with:

- (a) the Special District Information Program; and
- (b) the Board of County Commissioners of Orange County, Florida (as the "local general-purpose government within which the district is located" per Florida Statute 189.4043[1][b]).

Section 3. Effective Date. This Resolution shall become effective on November 4, 1991.
