RESOLUTION NO. 92-F/EMS-01

A RESOLUTION OF ORANGE COUNTY, FLORIDA, REPEALING A RESOLUTION WHICH CREATED THE APOPKA FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT; ENLARGING THE ORANGE COUNTY FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT BY INCLUDING THEREIN THE TERRITORY FORMERLY ENCOMPASSED WITHIN THE APOPKA FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT; ESTABLISHING THE LEVY AND COLLECTION AND AD VALOREM TAXES WITHIN THE SAID ORANGE COUNTY FIRE PROTECTION AND MEDICAL SERVICES MUNICIPAL SERVICE TAXING UNIT; AND PROVIDING AN EFFECTIVE DATE.

PREMISES

1. On March 3, 1986, by Resolution No. 86-F/EMS-03, the Board of County Commissioners erected by said Resolution the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit, which municipal service taxing unit encompassed all the unincorporated area of Orange County, Florida, save and except that territory encompassed within the Apopka Fire Protection and Emergency Medical Service Taxing Unit as that municipal service taxing unit was erected by the Board of County Commissioners by Resolution adopted May 12, 1981, which Resolution is found recorded in the Official Records of Orange County at Book 3194, Page 1045 thereof.

2. The Board of County Commissioners is of the opinion that there is no reason to maintain and continue a separate municipal service taxing unit for that geographical area

encompassed within the said Apopka Fire Protection and Emergency Medical Service Taxing Unit and that such territory should be combined with and consolidated into the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit in order that there be but one single fire and emergency medical services municipal services taxing unit, which unit shall contain all the unincorporated area of Orange County.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. That certain Resolution adopted May 12, 1981 and found recorded in the Official Records of Orange County at Book 3194, Page 1045 thereof, which establishes the Apopka Fire Protection and Emergency Medical Service Taxing Unit is hereby repealed effective upon the date of enactment of this Resolution.

Section 2. The geographical area contained within the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit shall be all the unincorporated territory of Orange County as of the date of enactment of this Resolution.

Section 3. There shall be levied within the Orange County Fire Protection and Emergency Medical Services Municipal Service Taxing Unit ad valorem taxes sufficient to fund the provision within the said taxing unit of fire and

emergency medical services, and services related thereto, which taxes shall be levied for the 1992 tax year, and all subsequent years, in accordance with law.

Section 4. This Resolution shall take effect upon its adoption.
