Florida desires that Orange County beautify and improve various rights-of-way within Orange County by landscaping. The City Council of the City of Orlando and the 2.

Board of County Commissioners of Orange County, Florida, hereinafter referred to as the "County", through interlocal agreement formed the Orange Blossom Trail Development Board, Inc. to accomplish the planning implementation of activities, development, public and private improvements and other projects intended to revitalize the Orange Blossom Trail.

- 3. The County has been informed that the Orange Blossom Trail Development Board wishes to apply for a Highway Beautification Grant from the Florida Department of Transportation to landscape portions of Orange Blossom Trail within Orange County.
- The County is being requested to provide funds from the Orange Blossom Trail Corridor Improvements and Orange Blossom Trail Neighborhood Improvements Municipal Services Taxing Units ("MSTU") to match those funds which may be awarded through the Florida Department of Transportation Highway Beautification Grant up to an amount of one hundred and fifty thousand and no/100 dollars (\$150,000.00).

5. The County specifically recognizes that maintenance of landscape improvements to the Orange Blossom Trail shall be the ongoing responsibility of the Orange Blossom Trail Development Board, Inc. and incorporated as part of other MSTU project maintenance.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. The County hereby authorizes the Orange Blossom Trail Development Board, Inc.'s application for a Highway Beautification Grant from the State of Florida Department of Transportation.

Section 2. The County hereby authorizes the use of up to one hundred fifty thousand and no/100 dollars (\$150,000.00) payable from the Orange Blossom Trail Corridor Improvement and Orange Blossom Neighborhood Improvement MSTU's as a local match of funds which may be awarded by the Florida Department of Transportation Highway Beautification Grant in accordance with a Memorandum of Agreement to be executed by the Florida Department of Transportation and the Orange Blossom Trail Development Board.
