ORANGE COUNTY SESQUICENTENNIAL  
COORDINATING COMMITTEE.

WHEREAS, in 1995 Florida celebrates its 150th Anniversary of Statehood; and

WHEREAS, the Florida Legislature enacted CHAPTER 94-152. Laws of Florida, establishing the Florida Sesquicentennial Commission to lead and coordinate the Florida Sesquicentennial; and

WHEREAS, Orange County Board of County Commissioners has been asked by the Florida Department of State to appoint a Sesquicentennial Coordinating Committee, ("the Coordinating Committee") for Orange County; and

WHEREAS, the Department of State also asked for the County to name the office of Chair and Vice-chair of the Coordinating Committee at the time of the appointment of the Coordinating Committee members; and

WHEREAS, the Coordination Committee will be charged with the primary responsibility of encouraging, sanctioning and coordinating local activities and events celebrating the sesquicentennial to take place within Orange County.

Sara Van Arsdel, Director, Orange County Historical Museum


4. The Vice-chair of the Coordinating Committee shall be:


