A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA ESTABLISHING THE MILEAGE RATES TO BE PAID TO COUNTY EMPLOYEES AND FURTHER ESTABLISHING THE MONTHLY PRIVATE MOTOR VEHICLE MILEAGE ALLOWANCE FOR COUNTY COMMISSIONERS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Legislature of the State of Florida has enacted amendments to Section 112.061(7) (d) (1), Florida Statutes, whereby the mileage rate for public employees using their private motor vehicles for public business may be reimbursed by their employing authority at the rate of twenty-nine (\$0.29) cents per mile for such use, effective July 1, 1995 and

WHEREAS, the Board of County Commissioners finds that said rate of twenty-nine (\$0.29) cents per mile is equitable and should be applied as the mileage reimbursement for employees of Orange County, Florida who use their private vehicles to execute County business and

WHEREAS, it seems reasonable and prudent to the Board of County Commissioners that the rate of County mileage reimbursement to be paid in the future should be equivalent to that authorized to be paid to public employees by the Florida Legislature,

WHEREAS, Resolution 90-M-36 of the Board of County Commissioners established a monthly travel allowance to be paid by the County to each Commissioner, the amount of said monthly travel allowance to be a lump sum based on a finding that each Commissioner is reasonably presumed to drive his or her private motor vehicle approximately one thousand (1,000) miles monthly, while carrying out county business,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA, THAT:

Section 1. Except as provided below, any employee of Orange County, Florida who, with the approval of his or her

45 Department Manager or the designee of that Department  
47 Manager, uses his or her private motor vehicle for the  
47 execution of County business shall be entitled to a County  
mileage reimbursement for such use.

49 Section 2. The County mileage reimbursement rate for  
County employees shall be twenty-nine (\$0.29) cents per mile,  
51 effective July 1, 1995. Further, effective July 1, 1995,  
such County mileage reimbursement rate shall thereafter be  
53 the same amount as that amount set forth by statute as the  
mileage reimbursement rate then currently payable to Florida  
55 state employees. Notwithstanding the foregoing, any County  
employees that received an automobile allowance as of  
57 September 1, 1992, shall not receive any mileage  
reimbursement for local travel.

59 Section 3. Each member of the Board of County  
Commissioners of Orange County, Florida shall receive a  
61 monthly travel allowance as reimbursement for use of his or  
her privately owned motor vehicle for travel on official  
63 business.

The amount of such monthly travel allowance shall be  
65 equal to the then current County mileage reimbursement rate  
per mile multiplied by one thousand. Such amount is found to  
67 be reasonable, taking into account the customary use of the  
automobile, the roads customarily traveled by a Commissioner,  
69 and the expenses incident to the ownership of an automobile.

71 Section 4. All prior Resolutions and Administrative  
72 Regulations adopted by this Board which may be inconsistent  
73 with the terms of this Resolution are hereby repealed to the  
74 extent to such inconsistency.

75 Section 5. This Resolution shall become effective upon  
76 adoption.

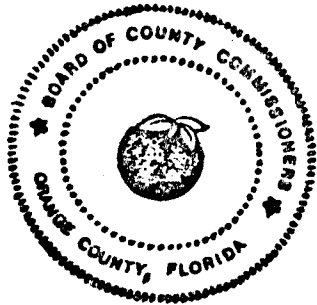
