RESOLUTION OF THE ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS CONTINUING THE 1985 MANDATORY REFUSE PROGRAM, INCLUDING THE RECYCLING PROGRAM AND SETTING THE CALENDAR YEAR 1997 SPECIAL ASSESSMENT AT \$154.24, AND SETTING THE ANNUAL RATE OF COMPENSATION FOR FRANCHISEES AT \$149.08 PER RESIDENTIAL UNIT

WHEREAS, Section 32-160(k)(1), Orange County Code, requires that all persons owning property entitled to full service shall be obligated to pay a charge for full solid waste collection service; and

WHEREAS, Section 32-160(k)(1), Orange County Code, requires that the assessments necessary to subsidize solid waste collection and recycling shall be set by resolution of the Board of County Commissioners after public hearing with public notice in the same manner as for county ordinances; and

WHEREAS, as copy of this resolution has been published in the Orlando Sentinel at least fifteen (15) days (excluding Sundays and legal holidays) prior to this September 12, 1995 hearing; and

WHEREAS, the Board County Commissioners did on June 25, 1996, tentatively set the amount for garbage collection for calendar year 1997 at \$154.24.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. The calendar year 1997 installment of the 1985 mandatory garbage collection and recycling special assessment program is hereby established at \$154.24. Such installment is necessary to subsidize the cost of providing garbage collection and recycling service to 144,263 residences in 1997 at an annual estimated cost of \$22,251,125.00.

Section 2. The mandatory refuse collection and recycling charge shall continue to be imposed upon any parcel of land within unincorporated Orange County on which is located: a mobile home park not exceeding four (4) dwelling units, mobile home subdivisions, single family residences, and multi-family residences not exceeding four (4) dwelling units under one common roof. Each dwelling unit in a multi-family residence shall constitute a separate benefit unit.

Section 3. The mandatory refuse and recycling special assessment program shall continue through calendar year 1997 in all respects as described in Orange County Resolution 85-SW-06, as amended, which created the Municipal Service Taxing Unit and Orange County Ordinance 85-17, as amended, providing for the procedures by which solid waste shall be collected and disposed of in Orange County. The special assessment shall

be collected in the same manner as ad valorem taxes.

Section 4. The annual rate of compensation paid to the franchisees providing collection services is hereby established at the rate of \$149.04 per residential unit.

Section 5. This resolution shall take effect immediately.
