RESOLUTION NO. 97-M-22

A RESOLUTION ESTABLISHING A WATERCRAFT IDLE
SPEED ONLY LIMIT ON A PORTION OF LAKE DOWN;
PROVIDING A PENALTY; PROVIDING FOR;
SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Orange County Board of County Commissioners is authorized by ordinance and state statute to establish boat and watercraft speed limits applicable to waterways located in all portions of Orange County including those waterways located within incorporated areas in Orange County not governed by a city ordinance in the same subject matter; and

WHEREAS, the Orange County Board of County Commissioners, hereby determines that an idle speed only limit on that portion of Lake Down located within Orange County and more particularly described below is necessary in order to protect the health, safety, and general welfare of citizens of Orange County.

**BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS
OF ORANGE COUNTY, FLORIDA:**

Section 1. A restricted speed limit of idle speed only on that portion of the open waterways within Orange County of Lake Down more particularly described as that area north and east of Conroy Windermere road from the existing No Wake Zone sign along western edge of the cove to the southeast shore of the cove located adjacent to Conroy Windermere Road which is directly north of the Lake Down Public Boat Ramp. A map depicting the idle speed only area is attached hereto as Exhibit A and is incorporated by this reference.

Section 2. Windermere Game and Fish Patrol is hereby directed to take those actions necessary to post the idle speed only area.

Section 3. A copy of this Resolution is being furnished to the Sheriff and State Attorney of Orange County.

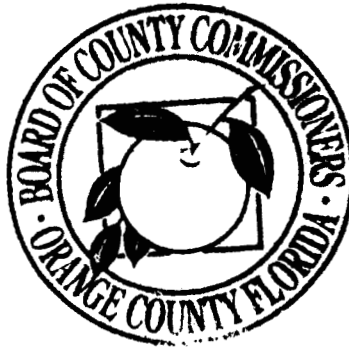
Section 4. **PENALTY.** Violators of this Resolution shall be subject to penalties for careless operation of a boat, motorboat, or vessel, in the manner provided by general law.

Section 5. **SEVERABILITY.** If any provision of this resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the resolution which can be given effect without the invalid provisions or applications, and to this end the provisions of this Resolution are declared severable.

Section 6. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption.
