**RESOLUTION OF THE ORANGE COUNTY BOARD OF  
COUNTY COMMISSIONERS AUTHORIZING THE  
APPLICATION FOR FUNDING THROUGH THE COUNTY  
EMERGENCY MEDICAL SERVICES AWARD PROGRAM**

**WHEREAS**, the Board of County Commissioners recognizes the need for emergency medical services in the county; and

**WHEREAS**, the Board of County Commissioners is familiar with the program made available through the State of Florida, Department of Health, Bureau of Emergency Medical Services, commonly known as the County Emergency Medical Services Award Program, and requests financial assistance through that program; and

**WHEREAS**, Orange County, Florida is a charter county and political subdivision of the State of Florida, and is therefore duly qualified by law and authorized to participate in said program with the Florida Department of Health, Bureau of Emergency Medical Services, and does desire to so participate, and

**WHEREAS**, the Board of County Commissioners recognizes that no other resources exist to provide these particular project goals to the County of Orange.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Orange County, Florida, in regular session duly assembled on this date, authorizes the application for funding through the County Emergency Medical Services Award Program, and that the Orange County Chairman is hereby authorized to execute any and all documents, contracts, and papers necessary to carry out the purposes of this resolution as stated herein.

**BE IT FURTHER RESOLVED** that the Board of County Commissioners of Orange County, Florida, intends to comply with all appropriate rules and regulations pertaining to the administration of this program.

THE ORANGE COUNTY BOARD OF COUNTY COMMISSIONERS hereby certifies that the County Emergency Medical Services Grant monies will be used to improve and expand the county's pre-hospital EMS system and that the funds will not be used to supplant existing county EMS budget allocations.

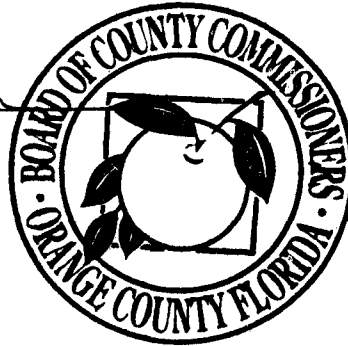
