RESOLUTION NO. 98-M-21

WHEREAS, Section 163.3191, Florida Statutes, requires that Orange County prepare and adopt an Evaluation and Appraisal Report; and

WHEREAS, Chapter 9J-33.005, Florida Administrative Code, requires that the adopted Evaluation and Appraisal Report be submitted to the Florida Department of Community Affairs for sufficiency review by July 1, 1998; and

WHEREAS, the amendments must be adopted by July 1, 1999, unless a six-month extension is given by the Florida Department of Community Affairs; and

WHEREAS, the Orange County Local Planning Agency held a public hearing on March 25, 1998, and transmitted the Evaluation and Appraisal Report to the Board of County Commissioners for review; and

WHEREAS, the Board of County Commissioners held a public hearing on June 23, 1998, for adoption of the Evaluation and Appraisal Report.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

Section 1. Adoption of Evaluation and Appraisal Report. The Orange County Board of County Commissioners hereby adopts the Evaluation and Appraisal Report of the Orange County 1990-2010 Comprehensive Policy Plan by this reference. A copy of the Evaluation and Appraisal Report is on file with the Clerk of the Board of County Commissioners and the Orange County

Planning Department, both located at 201 South Rosalind Avenue, Orlando, Florida.

Section 2. Submittal of Copy to Florida Department of Community Affairs. A copy of the adopted Evaluation and Appraisal Report shall be submitted by the Planning Department on or before July 1, 1998, to the Florida Department of Community Affairs for sufficiency review.

Section 3. Request for Extension. Orange County through the Planning Department shall request a six-month extension so that the amendments to the Comprehensive Policy Plan based upon the recommendations of the Evaluation and Appraisal Report shall be adopted by January 1, 2000. Orange County shall retain the option of adopting such amendments at a later date, as otherwise provided by Section 163.3191(6), Florida Statutes, as amended.

Section 4. Effective Date. This Resolution shall take effect immediately upon its adoption.
