The EMS Office of the Medical Director requests the approval of the renewal Certificate of Public Convenience and Necessity for Winter Park Fire-Rescue. Winter Park Fire-Rescue has submitted the attached application requesting the renewal of their Certificate of Public Convenience and Necessity to provide Advanced Life Support Transport Service. The current Certificate has been in effect as an Advanced Life Support Transport Service since 1996 and formerly as an ALS Non-Transport since 1983.

The EMS Office of the Medical Director has determined that all requirements have been met by Winter Park Fire-Rescue as contained in Orange County Ordinance 2001-9.

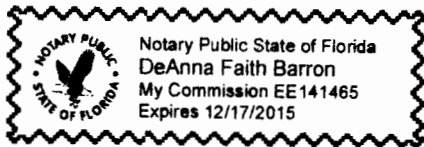
