

RECOMMENDATION

Selection of one firm and two ranked alternates to provide Construction Cost Estimating and Scheduling Evaluation Services, RFP Y15-197-LC, from the following firms listed alphabetically:

AECOM

Atkins North America, Inc.

Cost Management Inc. d/b/a CMI Montgomery Consulting Group, Inc.

PMA Consultants LLC

Request authority for the Procurement Division to negotiate and execute a 1-year contact within a budget amount of \$297,000. The Procurement Division also requests the authority to renew the contract for two additional 1-year periods.

Proposals were evaluated by the Procurement Committee on March 11, 2015. Commissioner Bryan Nelson was assigned to the Procurement Committee.

<u>PURPOSE</u>

To provide construction cost estimating, scheduling and/or evaluation services.

DISCUSSION

Services will be provided for new construction, remodeling and renovation or repair of facilities and buildings. These services may require the consultant to prepare independent, objective, detailed cost estimates and/or schedules, evaluate and negotiate claims and change orders. This contract will be primarily used by the Capital Projects Division and the Orange County Convention Center (OCCC). Other County divisions will have access to the contract if necessary.

The proposals from Blue Cord Design and Construction, PSA Construction, Inc., and Theobald Construction scored too low for Board consideration.

The Procurement Committee's evaluations are attached.
