The Orange County Sheriff's Office is requesting \$2,500 from the Law Enforcement Trust Fund for the following purpose:

Contribution:

Images of Glory - Young Seeds of Virtue - \$2,500. This organization works with female survivors of human trafficking, underprivileged girls and those that are homeless throughout the State of Florida. They embrace young women from all demographics and provide outreach by equipping girls to become valuable members of society.

ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$2,500 from the Law Enforcement Trust Fund to provide eligible contributions to the Images of Glory - Young Seeds of Virtue.

PLEASE NOTE: The Board voted to establish spending limits of 20% for this fund for contributions. At this point in the year, contributions represent 6% of the total expenditures; however, the restriction applies to total expenditures for the year, at year-end. The Sheriff's Office has stated that they monitor their expenditures, and that they will not exceed the 20% total for contributions.
