ACTION REQUESTED:

Approval to award Invitation for Bids Y16-761-EB, Bithlo Highway Maintenance Facility Perimeter Fence, to the low responsive and responsible bidder, All-Rite Fence Services, Inc., in the total contract award amount of \$126,335.

PROCUREMENT:

The project entails the removal of existing fence and installation of new fencing and gates around the perimeter of the Bithlo Highway Maintenance Facility. The new fence system will include (1) 20' wide double drive swing gate, one 34' wide double drive swing gate and (1) 21' wide cantilever drive gates. The project is located in District 5.

FUNDING:

Funding is available in account number 1004 072 2947 6310.

APPROVALS:

The Facilities Management Division and Business Development Division concur with this recommendation.

REMARKS:

Four bids were received. All-Rite Fence Services, Inc. has a satisfactory record of performance and has been determined responsible. Therefore, award is recommended to All-Rite Fence Services, Inc.

SUBJECT: Business Development Division Bid Evaluation

PROJECT: **Y16-761-EB / Bithlo Highway Maintenance Facility Perimeter Fence**

The Business Development Division evaluated the 3 lowest bids of the 4 bids submitted for this project and found that the apparent low bidder All-Rite Fence Services, Inc. did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

The second low bid submitted by Sterling Enterprises, LLC did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

The third low bid submitted by Commercial Fence Contractors, Inc. did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

None of the bids met the the MWBE sliding scale range criteria to be awarded this contract over the low bidder.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page. If the low bidder is not chosen, please let us know so that we may obtain Letters of Intent to confirm the participation.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
